# 'Lau for Judge' Campaign New Website Clarifies Differences vs. Opponent

Lau's Waukesha County experience, support, commitment clearly makes her local choice

WAUKESHA COUNTY—MARCH 19, 2018—The Lau for Judge campaign today launched LauForJudge.com.
