PACKERS QB AARON RODGERS JOINS FIGHT FOR EQUAL JUSTICE FOR ALL

Team Makes Donation to Help Provide Civil Legal Aid to Poor and Elderly

Green Bay, WI — Legal Action of Wisconsin received a \$50,000 donation from five player representatives of the Green Bay Packers at Lambeau Field today.

On behalf of Quarterback Aaron Rodgers, Packers President and CEO Mark Murphy presented the donation to Legal Action. The donation is part of the players' and the NFL's *Social Justice Initiative*—a joint effort between the players and the NFL to use their platform to tackle the complex societal issues in their communities.

Legal Action Executive Director David Pifer, along with Legal Action Board President Ben Obregon, joined Andrea Gage-Michaels, the managing attorney of Legal Action's Green Bay Office, to accept the donation. Pifer was pleased to announce that the players will continue to support Legal Action after today's event.

"Social justice is our work. Equal justice for all is our work. Aaron Rodgers' and the other players' choice to support Legal Action of Wisconsin affirms that equal justice for all is one of the most important American ideals," said Pifer. "Demanding equal justice for all is what we have done for 50 years, and what we will continue to do as long as it is needed."

They are elderly men and women, students, veterans, and people with disabilities. They are working moms and dads" said Gage-Michaels.
