RE: **Finalized Calendar for Tuesday, February 11th**

The Assembly committee on Rules has scheduled the following legislation for session **convening at 1:00 P.M. on Tuesday, February 11th**.

Please note it is our intention to take up **AB 344 (Quinn)** from the November 12th delayed calendar. AB 344 relates to: telephone company tax exemption for property used to provide broadband service.
