## State Superintendent-elect Jill Underly Announces Transition Team

(Madison, WI) — State Superintendent-elect Jill Underly announced today her Wisconsin Department of Public Instruction (DPI) transition team, made up primarily of volunteers.

“Our transition will be advised by a team with diverse experience in public education and libraries,” said Dr. Underly. “They represent a broad group of stakeholders and each bring a passion for public education and a commitment to helping our new administration fulfill our pledge to build a public education system where every child gets what they need to succeed, every day.”

The transition team will meet periodically, provide advice and counsel, and help connect Dr. Underly to various communities and stakeholders across the state.

**Erin Forrest** is serving as Transition Director. She is an experienced organizational leader who most recently worked in the adult training and women’s empowerment space. Erin is a proud Wisconsin public schools graduate and the parent of two Wisconsin public school kids.

**Sachin Chheda** is serving as senior advisor to the transition. He is an experienced communications, government relations, advocacy and nonprofit management professional, who previously has served as a senior aide to a Governor and a UW-Milwaukee Chancellor. He oversaw Underly’s campaign for Superintendent, and has four children attending or graduated from Milwaukee Public Schools.

**Susie Crazy Thunder**, Anishinaabe name of Giiwedinookwe (North Wind Woman), is a member of the Red Cliff Band of Lake Superior Ojibwé. She is the Tribal Outreach Coordinator for Nicolet College and has served on the board of the Wisconsin Indian Education Association since 2016.

**Angelina Cruz** has been a public school teacher in the Racine Unified School District (RUSD) for the past eighteen years. She is currently the President of Racine Educators United, a public educator union comprising the Racine Education Association and the Racine Educational Assistants’ Association.

**Kim Kaukl** grew up in Richland Center, WI, earned degrees from UW-La Crosse and UW-Madison, and served 34 years as a teacher and administrator in schools of varying sizes. He is currently the executive director of the Wisconsin Rural Schools Alliance.

**Trish Kilpin** is in her 30th year as a Greendale School District School Social Worker. She was named the Wisconsin School Social Worker of the Year in 1997, and Wisconsin Teacher of the Year in 2021. She believes that the social, emotional and cognitive facets of learning are deeply linked.
