Bill to Return Personal Property Aid Payments Signed into Law

Today a bill that ensures the distribution of personal property taxes to applicable taxing jurisdictions after the termination of a tax incremental district was signed into law. This law is a responsible and necessary step in returning taxpayer dollars to the jurisdictions that will benefit the most from them. These jurisdictions include the municipality covered by the tax incremental district, school boards, and counties.

“A big part of my job as an elected official is ensuring the responsible stewardship of taxpayer dollars,” said Representative Steffen. “This bill will return money to the pockets of local governments, which will greatly benefit the hardworking men and women of Wisconsin.”

This bill clarifies that personal property aid payments the state makes to a TIF District continue after the TID closes, but transfer to the municipality and other taxing jurisdictions. The 2017-2019 state budget created a new personal property tax exemption, sec. 70.111(27), for machinery, tools, and patterns, not including such items used in manufacturing.

“It only makes sense that when a tax incremental district is closed, the aid payments should continue to flow to the affected taxing jurisdictions,” said Steffen. “The money that they receive in the form of these aid payments is money that came from their pockets.”
